Interested consulting firms must provide information indicating that they are qualified to perform the services [company profile, brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc. with supporting documents to substantiate the information provided in the EOI]. - 3. A consulting firm will be selected in accordance with the procedures set out in the Nepal Government's Service Procurement Policy (i.e. Public Procurement Act 2063 and Regulation 2064).
- 4. The consulting firms will be evaluated and shortlisted based on the approved evaluation criteria that are broadly based on the following categories.
 - A. Eligibility Criteria i) Valid registration certificate; ii) Tax clearance or renewal of tax certificate; iii) VAT/PAN registration certificate;iv) consulting firm must be registered since last THREE years. Failure to meet the eligibility criteria means automatic disqualification.
 - B. Ranking Criteria: Ranking criteria are broadly based on the following three categories. i) General Experiences: Number of Projects Completed Successfully ii) Specific/Similar/Relevant Experiences (each completed project not less than value of 2 million Nepali Rupees): i) Number of completed projects related to design and development of national database and information system; ii) Number of completed projects related to design and development of national database and information system for natural resource sector; iii) Number of completed projects related to design and development of database and information system for forestry sector and iv) Number of completed projects related to design and development of database for climate change adaptation and REDD. iii) Organizational setup of the consulting firm: office, equipment, office organization and management and annual turnover taken for the best two years from last three years.
- Expression of Interest must be clearly marked "Expression of Interest (EOI) for consulting services for development of national of basic attributes of all forest management regimes for Mid, Mid-Western and Far-Western Development Regions and data feed into National Forest Information System(REDDIC/NFD/2072-73).
