Request for Bids for the Procurement of Software and Lab Equipment

1. The REDD Implementation Centre has received financing from the World Bank and intends to apply parts of the proceed towards payments for two separate bids: 1) Supply, delivery and installation of Arc GIS Software, Server Backup Storage, UPS, Plotter, etc. (Ref No. NP-REDD-211667-GO-RFB), and 2) Supply, delivery and installation of Oven, Fume Hood, Hot Air Drier, etc. for Soil Laboratory (Ref No. NP-REDD-211668-GO-RFB).
2. A complete set of Bidding Documents may be downloaded from the office website: www.redd.gov.np or PPMO's e-GP system i.e., www.bolpatra.gov.np/egp by eligible Bidders upon payment of a non-refundable fee of NRs. 3000.00 in Revenue Account No. 1000200010000, Office Code 329013503, Revenue Head 14229 at Rastriya Banijya Bank during office hours.
3. Bids must be submitted through e-GP system i.e. www.bolpatra.gov.np/egp on or before 12.00 Noon on 2021/03/26. Bids received after this deadline will be rejected.
4. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1.00 PM on 2021/03/26 at the office of REDD Implementation Centre, Babarmahal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by the bid security which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. 1201200-001-002-524 Office Code: 329013503 at Nepal Rastra Bank and submit the receipt of the deposited amount of cash along with the Bid.
5. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
6. The Purchaser reserves the right to accept or reject, wholly or partly any or all the Bids without assigning any reason, whatsoever.
