1. The Government of Nepal has received the FCPF grant from the World Bank toward the cost of Nepal REDD Readiness Preparation Program and intends to apply part of the proceeds for the following consulting services.

 2. **Individual National Consultant (Environmental Lawyer)** for Developing a System of Feedback and Grievance Redress Mechanism (GRM: FCPF/REDD/S/IND-33
